Treating NVLD in Children: Professional Collaborations for Positive Outcomes

Presenter: Jessica Broitman, PhD, Jack Davis, PhD and Marion Marshall, MS, BCET, FAET

When: September 20, 2013 (Friday) Time: 12:30 - 2 p.m.

Location: 1375 55th Street, Emeryville

This presentation will provide an overview of the authors' new book, *Treating NVLD in Children: Professional Collaborations for Positive Outcomes*. The goal is to familiarize the audience with the need to think collaboratively when working with children with Nonverbal Learning Disabilities (NVLD), as their symptomatology can be very diverse and may require the need to involve a variety of professionals over the course of their childhood to early adulthood. Marion Marshall will present an example of such a professional covering the role of an educational therapist.

Jessica Broitman, PhD is co-editor of Treating NVLD in Children: Professional Collaborations for Positive Outcomes (2013), and also co-author of Learning Disabilities in Children: Bridging the Gap Between Science and Practice (2011). Dr. Broitman is the President emeritus of the San Francisco Psychotherapy Research Group and Executive Director of its Clinic and Training Center. She frequently lectures on Weiss's Control Mastery Theory worldwide. Currently a psychoanalyst in private practice since 1980, she has worked with families who have learning-disabled children for more than 10 years. She is currently involved in several research projects concerning the treatment and understanding of NVLD and has a special interest in helping professionals and families understand and treat this disorder.

Jack Davis, PhD is co-editor of Treating NVLD in Children and co-author of Nonverbal Learning Disabilities in Children: Bridging the Gap Between Science and Practice (2011). He is currently a Professor at California State University, East Bay, and Chair of the Educational Psychology Department, where he teaches and supervises. He received his PhD from the UC Berkeley School Psychology program and is a licensed psychologist. Dr. Davis has a special interest in learning and developmental disorders having been the director of a school and clinic for students with learning disabilities for 13 years, which provided diagnostic and intervention services. His current clinical work is primarily with children and adults with learning disorders. His writing and research interests include articles and book chapters in the areas of mental health consultation, suicide/crisis intervention, and learning disorders.

Marion Marshall, MS, BCET, FAET, is a multiple award-winning educator with over 34 years of experience teaching in public and independent schools. She is an Associate Professor of Education at Holy Names University in Oakland where she serves as the Coordinator of the graduate-level Educational Therapy Program. Ms. Marshall has been honored with "Teacher of the Year, Resource Specialist" for the State of California, and named a Fellow in Educational Therapy for outstanding contributions

to the field. She is currently a Board Member for the Association of Educational Therapists (AET) and her work has been published in the AET Journal.

Psychotherapy Process and Outcome Research

Presenter: Meghan Tiedemann-Fuller, PhD

As psychotherapy research has developed and become more complex and nuanced, its significance to clinicians has increased. Recent studies have given us greater insight into how therapist and patient impact one another, what types of interventions or aspects of therapy lead to short- and long-term changes, and how psychotherapy affects the brain. This presentation will provide an overview of psychotherapy process and outcome research, with an emphasis on its relevance to clinical practice. Clinical dilemmas with regard to gathering data and patient and therapist participation in research will be discussed.

Meghan Tiedemann-Fuller, PhD is a fellow of the Anna Freud Centre Research Training Program at the Yale Child Study Center and of the American Psychoanalytic Association. She is in private practice in San Francisco and Napa, where she works with children, adolescents, and adults.

DSM-5 Transitions

Presenter: Stan Taubman, PhD, LCSW

This presentation will introduce participants to major changes from the DSM-IV to the DSM-5 including changes in the classification system, definition of mental disorder, loss of the 5 axis system, new diagnoses, deleted diagnoses, and criteria changes. The presentation will also introduce the new Severity Rating Scales, Cross-Cutting Symptom Measures and Disability Assessment Schedule. The focus will be on diagnoses and assessment measures that are most relevant to child, youth and family practice. In view of the brief nature of this presentation the presentation will be geared to those who are familiar with the DSM-IV and interested in changes made in the new edition of the diagnostic manual.

Stan Taubman, PhD, LCSW has taught clinical diagnosis workshops since the advent of DSM-III in 1979. He is the former Director of the Alameda County Medi-Cal Behavioral Health Plan and Director of Management Services for the Alameda County Behavioral Health Care Services. Dr. Taubman's clinical practice experience since 1968 includes mental health, medical, child welfare and private practice settings, and he has served on the faculties of the UCLA Neuropsychiatric Institute, USC, San Diego State University and UC Berkeley.

Legally Defensible Reports Pursuant to the Individuals with Disabilities Education Act
