

Apply Now! Ohio International Market Access Grant for Exporters (IMAGE)

IMAGE is designed to help small Ohio businesses promote their products and services in international markets. Qualifying Ohio companies can apply for a 50% financial reimbursement worth up to \$6,000 to offset the costs of export-related activities such as international trade shows and missions, subscription to services provided by the U.S. Commercial Service, export education programs, and marketing and translation services.
