Understanding the Links in the Chain of Evidence

More and more healthcare workers are being asked to collect and preserve evidence before law enforcement professionals arrive. As more professionals with unique responsibilities and skill sets are being called upon to interface, having an understanding of each other's unique expertise will enable everyone who impacts an investigation and trial to interact more effectively. Collaboration, continuity in processes and techniques and effective communication between all parties is critical for a successful prosecution and for the victim's healing process to begin.

**FORENSIC HEALTHCARE: Understanding the Links in the Chain of Evidence** seminar defines and details the forensic process from initial contact through court room trial. The critical links in the chain will be identified along with best practices, tips and perspectives from industry experts.

## THE PROGRAM

- **Incident** – Hear a firsthand account from the last victim of the Society Hill Strangler (Philadelphia) of her emergency room experience and how she is advocating for DNA samples to be collected by hospital personnel for all assault victims, not just sexual.
- **Recognition, Recording, Reporting** – SANE nursing professionals will detail how they counsel victims and provide practical information on the process of collecting and preserving evidence once an assault had been identified.
- **Evidence Examination** – Understand how evidence is examined by law enforcement and how to avoid the common mistakes that can derail an investigation.
- **Investigation** – Hear two local Special Victim Unit detectives detail how they piece together the incident and what they require from the other links to present sufficient evidence to the Prosecution.
- **Prosecution** – What if you were called upon to testify to help with the prosecution and begin the victim's healing process? Would you be prepared? Learn helpful tips and perspective from a local prosecutor and judge to make the experience more comfortable and successful.
- **Panel Discussion** – The event concludes with a panel discussion focusing on how forensic awareness can be integrated into the healthcare provider's focus, the patient. Q & A and evaluation will conclude the program.
