

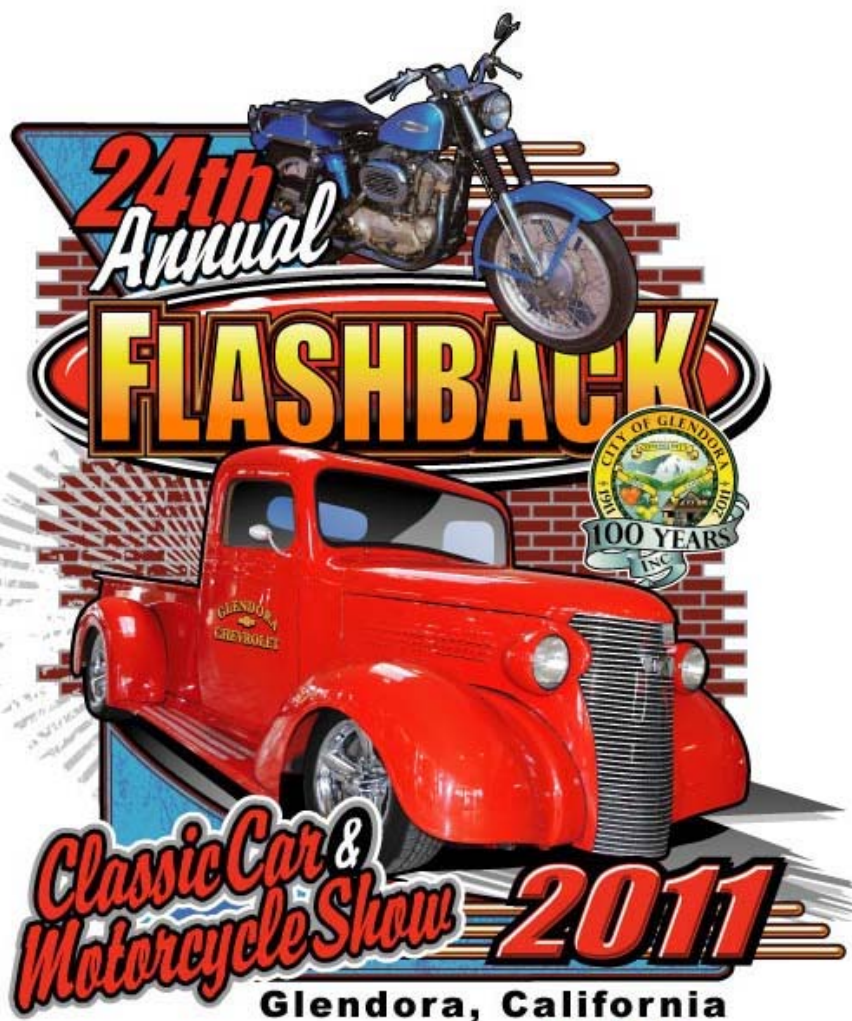

LEGISLATIVE ACTION CORNER

Dr. Cliff Hamlow

Azusa Pacific University

Assemblyman Tim Donnelly addressed about 50 chamber members at the Chamber's Legislative Action Committee luncheon hosted by America's Christian Credit Union recently. In his address he gave several insights into the still unsettled budget. It boils down to whether the state is going to make the necessary spending cuts or whether they are going to saddle the public with more taxation. Assemblyman Donnelly spoke about his open relationship with Gov. Brown and their desire to communicate in spite of their differences in how to address the budget deficit.

The Chamber thanks Mendell Thompson, CEO of America's Christian Credit Union, who underwrote the costs of providing the luncheon and Fawn Imboden who made all the arrangements. We who live in Glendora appreciate the generosity of many of our Chamber businesses who support the efforts of the Chamber.

Glendora citizens should take part in the redistricting committee's work as they draw the lines that we will live with for the next 10 years as they define the Assembly, Senate, and U S Congressional districts. The first round of maps were released June 10th and it would appear that the U.S. Congressman's District containing Glendora will divide the city – it is hard to distinguish but it seems like the dividing line would be a north-south divide using the 210 freeway. This is not acceptable as one of the core values of the "we draw the lines" initiatives was keeping communities together. Currently our representatives are Congressman David Dreier, State Senator Bob Huff and Assemblyman Tim Donnelly. These Districts have been pretty much gerrymandered so we should expect some change.

VOTERS FIRST ACT CRITERIA FOR DRAWING DISTRICTS ARE AS FOLLOWS:

The California Constitution lists and ranks the criteria drawing district boundaries as follows:

- (1) Districts shall comply with the United States Constitution. Congressional districts shall achieve population equality as nearly as practicable, and Senatorial, Assembly, and State

Metro Gold Line Foothill Extension

June 2011 Updates

Pasadena to Azusa Extension:

Skanska USA (contractor) began mobilizing equipment and installing temporary facilities for the construction of the I-210 Bridge (Bridge) that will allow connection between the existing Sierra Madre Villa Station and the future Arcadia Station. Crews will soon begin grading the slopes of the center and southern medians to stage equipment and begin foundation work.

Periodic lane closures of all eastbound lanes between Baldwin Avenue and Santa Anita Avenue will occur throughout the 12-month construction period. Closures will be limited to late night hours (from Midnight to 5:00 a.m.) and traffic will be detoured off the freeway.

Award of the design-build contract is anticipated in July for the Pasadena to Azusa Alignment package for the construction of the six stations, maintenance and operations facility, 11.5-miles of track, crossing and much more. Construction on the Pasadena to Azusa Alignment will commence in mid-2012 with completion in early 2015.

Stay Safe: Always Call 811 Before You Dig

As we head into the warmer months, SoCalGas wants to remind customers and contractors to “call 811 before they dig” in their yard or construction site. Doing so will help avoid damaging buried natural gas lines and help avoid unnecessary and costly damage, possible injury or service interruption.

Out of Sight...

Natural gas pipelines are located underground and out of sight, sometimes just inches below the surface. When customers or contractors are eager to begin a project that involves digging, they may overlook this. In fact, one of the most significant threats to pipeline safety is third-party damage, or “dig-ins.” Last year alone, there were over 2,200 customer and contractor preventable accidents caused by “dig-ins.” In more than half of those cases, no call was made to 8-1-1 to have lines located and marked.

Board of Equalization districts shall have reasonably equal population with other districts for the same office.

(2) Districts shall comply with the Federal Voting Rights Act (42 U.S.C. Sec. 1971 and following).

(3) Districts shall be geographically contiguous.

(4) The geographic integrity of any city, county, local neighborhood, or local community of interest shall be respected in a manner that minimizes their division to the extent possible without violating the requirements of any of the preceding subdivisions. A community of interest is a contiguous population which shares common social and economic interests that should be included within a single district for purposes of its effective and fair representation. Examples of such shared interests are those common to an urban area, a rural area, an industrial area, or an agricultural area, and those common to areas in which people share similar living standards, use the same transportation facilities, have similar work opportunities, or have access to the same media of communication relevant to the election process. Communities of interest shall not include relationships with political parties, incumbents, or political candidates.

(5) To the extent practicable and where this does not conflict with the criteria above, districts shall be drawn to encourage geographical compactness such that nearby areas of population are not bypassed for more distant populations.

(6) To the extent practicable, and where this does not conflict with the criteria above, each Senate district shall be comprised of two whole, complete, and adjacent Assembly districts, and each Board of Equalization district shall be comprised of 10 whole, complete, and adjacent Senate districts.

(7) The place of residence of any incumbent or political candidate shall not be considered in the creation of a map. Districts shall not be drawn for the purpose of favoring or discriminating against an incumbent, political candidate, or political party.

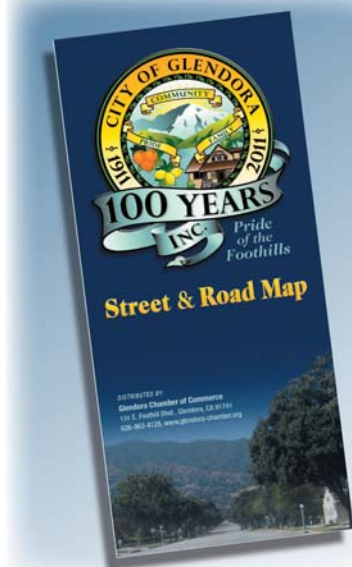

Azusa to Montclair Extension: Environmental review of the Foothill Extension from Azusa to Montclair is well underway.

The proposed project - which will extend the line 12.6-miles east of Azusa and include stations in Glendora, San Dimas, La Verne, Pomona, Claremont and Montclair – began the environmental process in January 2011. In April and May, community workshops were conducted for each of the station areas. Feedback received helped better define the station area plans and finalize the Project Description, which defines the project for environmental analysis.

Publication of the Draft Environmental Impact Statement/Environmental Impact Report is anticipated in August 2011. Clearing the project under state and federal regulations positions the project for possible state and federal funding.

Pipeline Safety: A Shared Responsibility

We take our pipeline safety responsibility very seriously. The public also has a responsibility. SoCalGas urges homeowners and contractors to make a quick phone call to Underground Service Alert at 811 at least two business days before digging in the yard or street to have utility-owned lines marked for free.

As a free service, Underground Service Alert will contact SoCalGas and other area utility owners to locate and mark the underground facilities they own. In addition to the distribution and transmission lines found throughout our service territory, SoCalGas-owned pipelines typically extend from the gas main in front of or behind the home or building to the gas meter. SoCalGas uses only yellow paint, flags or stakes to mark its gas lines. Other utility owners use other colors to mark their lines.

Customer-owned gas piping runs from the gas meter to a building or area where gas-fueled equipment or appliances are located. To have these customer-owned lines located and marked, SoCalGas advises customers to call pipe and leak locating service companies or plumbing contractors who provide these maintenance services.

Once all lines are marked, customers and contractors should carefully use only hand-digging tools within two feet on each side of marked gas and other underground lines to determine the exact locations of all underground lines in the area of the excavation.

Report Any Suspected Damage

No damage is too small to report. Even a slight gouge, scrape or dent to a pipeline or the pipe's coating may cause a break or leak in the future. If a customer or contractor discovers or causes what seems to be only minor damage to a pipeline, or any component attached to the pipeline, they should still notify SoCalGas immediately by calling 1-800-427-2200.
