Introductions- 4:05 → 4:10pm

Each attendant introduced themselves and the organization/faith community they represented. Each attendant expressed what has brought them into the coalition and their initiatives.

Reading of September Minutes

The minutes were read and discussed among the group.

- Comments/Decisions Made
 - Whitlie: Stated that she has started on the uploading of the materials needed for the NICHQ ILab for the months of August and September. There were a few items either missing or incomplete that she needed to investigate as to where the information was in order to complete the updates by the deadline. Asked about the team assessments and will find the results.
 - Michael: Explained the upcoming event" Lunch, Listen, & Learn". After the lunch, the members of the host congregation would stay behind and be interviewed. This is our first

event so we may start off shaky. The idea is to take the LL&L series to the other congregations. Michael did an overview of the agenda for the session. Michael suggested that we hold meetings before the LL&L sessions at the host site (possibly the week before), in order to get a head count of who has RSVP'd and to discuss how the sessions will run(meeting time, food, topics discussed, last minute planning, etc.). He will be following a moderator's guide which would be made and amended for the use of the other faith communities. This is a qualitative approach. LL&L sessions will meet on day of the week at the discretion of the host faith.

- Pat J.: Gave clarification on what the goal of this event and events like it are trying to accomplish. "We are trying to change the way we are getting information from the community. Because the way we have done it in the past is, we come up with the questions, put them out there, we have gotten answers, we develop programs based on those answers, but nothing has worked. All the statistics show that chronic diseases are continuing to increase in our community... We are trying to get the feedback from the community first. Michael is skilled in developing discussions to get information from people. Our goal is to have him train individuals so that they can go into the community and continue to gather this information, so that we can provide the kinds of programs and activities that can be useful in addressing the chronic disease issue."
- Lee: Is currently trying to find a location for the Baha'i LL&L in November. Wants the template for the LL&L invitations. Needs a document so that she can send it to the leaders in Baha'i.
- A decision was made that <u>Pat J and Pat S will write an overview/ structure for the LL&L</u> <u>sessions that the coalition leaders could send to their faith leaders that would explain the purpose of the LL&Ls.</u> Creation of a template was agreed upon so that the only items that'll need to be changed are the dates and locations.
- LL&L invitation and information sheet to be sent to Lee by October 19th.
- Michael: Hasn't heard back about the Walgreens Grant.
- Pat J: If you hear about any grants, please bring them to the group.
- Michael: We should hold off on accepting members until we get more programs under our belt and become more established. The main problem is properly getting the new members up to speed in a timely manner.
 - Lee: Thinks that if we have someone who wants to join and is enthusiastic, we don't have to take time out of the meeting to bring them up to speed. We could have someone pull them aside at another time in order to update them.

- Michael: Suggested that the monthly meetings be run as "Board of Directors" type meeting.
 Where the Coalition leaders meet and vote on items, then they go back and updated the other members of the coalition.
- Meeting accepted the meetings

Concerns/Suggestions

There was a unanimous concern about the attendance and involvement of other coalition leaders and members. Of the 10 organizations in the meeting only 5 of the organizations were represented.

- Pat S: Addressed the concern about creating the following: an attendance policy, guidelines of responsibilities, rules for receiving grant funds, and by-laws for those who have joined the coalition and new members as well.
- Nazeera: There are members who have not participated, have received funding, but not bothered to show up for meetings. They are here for just namesake. She suggested that they be removed and we add people who do take it more seriously.
- Michael: Suggests that a membership committee could create sort of a minimum standard of attendance, so that once it is defined we can hold them to it. We don't want to just dismiss them without them knowing the standard first.
- o Pat J: We need to start documenting what our processes and procedures will be.
- Michael: <u>Makes a motion to create a membership committee that would address all the issues</u>
 related to rules and standards of members wanting to join, new members, and current
 <u>members. Lee Lambert and Pat Smith were nominated as the co-chairs with the addition of Ken Lazarus. The motion was accepted</u>
- Lee brought up the idea of having a 5-minute meditation before each meeting. This suggestion was agreed upon, and would be incorporated into practice.
- Nazeera: Brings up the need for a marketing committee. One is needed to promote our programs the targets groups we are seeking, so that they will come to the programs, which will allow us to gather a greater pool of data.

Pat S. is waiting to be trained with Morehouse School of Medicine, as a community health worker. She needs letter of support from FCIC. The letter needs to be signed, and include the proper letter heads. UMC is preparing to add a First Aid and lactation room to their church facility. The room would be attached to the nursery. The room would double as a First Aid room that would help to assist those whom suddenly collapse or need emergency care during service or on church grounds, and as a private area to lactating mothers to feed their children. There will be a Healthy Eating Seminar Friday, October 26th offered by Helping Hands.

 Atlanta Regional Commissions is offering 15-20 free slots to their workshop for people to become trained as a Living Well Leader in Stanford's Chronic Disease Self-Management Program. Those wishing to become a leader should contact Fulton County so that dates for the classes can be set up.
