

BC Hydro Site C Clean Energy Project – Public and Stakeholder Consultation

BC Hydro is inviting local communities, stakeholders and the public to participate in upcoming Project Definition Consultation, Spring 2012 for the Site C Clean Energy Project (Site C). The consultation is taking place **April 10 through May 31, 2012.**

Site C is a proposed third dam and hydroelectric generating station on the Peace River in northeast B.C. It is being proposed as part of BC Hydro's overall regeneration program to invest in and renew the province's electricity system.

BC Hydro is undertaking Project Definition Consultation to gather stakeholder and public input on a range of topics important to project planning and the ongoing environmental assessment.
