Session I : Nov 30, 2:00 PM "Human Trafficking: Global Threat to Fundamental Human Rights"

Human trafficking is a form of modern-day slavery and has been reported in all 50 states, Washington, D.C. and U.S. Territories, as well as other countries. Victims of human trafficking are young children, teenagers, men and women. Victims are exploited for sex and forced labor. Traffickers use various techniques to control their victims and keep them enslaved. Many of these victims are forced to work in prostitution or the sex entertainment in-



dustry while other victims are recruited into labor exploitation as domestic servants, restaurant staff, hotel employees, factory workers and agricultural laborers.

In this workshop, participants will listen and interact with speakers that represent various perspectives on Human Trafficking: domestic and international trafficking, child sexual trafficking, prosecution of traffickers and services to victims. The presenters work daily to provide awareness of the problem, to abolish slavery, and vigorously prosecute those who break the law.

Ms. Susan Coppedge is Assistant United States Attorney for the Northern District of Georgia and has prosecuted a variety of criminal cases including human trafficking, fraud, and government corruption. Ms. Coppedge has spoken to national law enforcement in New Zealand, Thailand, Argentina and the United States on the investigation and prosecution of human trafficking cases. She served in Vienna, Austria as the only United States prosecutor on a United Nations Office Working Group developing an international reporting system for human trafficking.



Mr. Eskinder Negash is the Director of Office of Refugee Resettlement within the Administration for Children and Families at the U.S. Department of Health and Human Services. Mr. Negash brings nearly 30 years of experience working on behalf of refugees and immigrants. He previously served as the Vice President and Chief Operating Officer of the U.S. Committee on Refugees and Immigrants, dedicated to addressing the needs and rights of persons in forced or voluntary migration worldwide.



Ms. Jennifer Swain is program Manager A Future. Not A Past. Campaign & the Voices **Project** Agency – Ms. Swain has been passionately involved with serving commercially sexually exploited victims for the past four years. As the STOP CSEC Program Manager, she leads the program's current efforts to stop the demand for prostituted youth through the A Future. Not A Past. Campaign and to prevent youth deemed "high risk" from becoming child sex trafficking victims through the Voices Project.



Ms. Rebecca Posey serves as Georgia Director for Not For Sale, the global campaign to end human trafficking and modern-day slavery. In this role, she manages partner relations, leadership development, and public engagement, and communicates regularly with Not For Sale's 1000+ grassroots abolitionists throughout the state of Georgia. Rebecca acts as a community resource for information on domestic and international labor and sex trafficking, CSEC, smart activism, and socially responsible global business.

"Health Issues Impacting Families Internationally-"Social Determinants of Health and Their Impact around the Globe"

This session examines how social determinants of health, such as poverty, family environment, educations, jobs, food and water security and others, influence health outcomes across the world. Addressing these external factors can lead to positive change for many populations who suffer disparate treatment and lack necessary resources to adequately address their health challenges. Presenters will provide insights on



the connection of health outcomes and social determinants, as well as examine the Affordable Care Act and how it seeks to address health challenges here in the US.
