

## Gypsy Vanner Horse Society STALLION SERVICE SALE for the 2013 Breeding Year

### TERMS AND CONDITIONS

1. The 2013 Stallion Service Sale is normally 1/2 of the stallions normal stud fee. Fee and information is on the web site for each stallion offered.
2. Buyers must be at least 18 years of age to purchase a stallion service.
3. The stallions offered will be GVHS registered stallions and the service can only be purchased to breed a GVHS registered mare.
4. All posted stud fees are stated in and transactions will be in US dollars. Payments can be made by Visa or Mastercard in the GVHStore, or paypal.
5. A confirmation will be emailed to the purchaser of the stallion service and they will have 3 days to make payment. If payment not made within the 3 days the stallion service will be reoffered for sale.
6. The stallion services offered in this sale are intended for the 2013 breeding season.
7. A mare owner may purchase any number of stallion services. Once you purchase a stallion service you will be entering into a legal contract with the stallion owner and agree to abide by the terms and conditions of the stallion owner's breeding contract. Purchases are final and no refunds will be given.
8. Mare owners are responsible for contacting stallion owners prior to purchasing the stallion service to become familiar with their Breeding Contract and expenses associated with breeding to the stallion, and to ensure that their mare meets the approval of the stallion owner. **BOOKING FEES, COLLECTION FEES and SHIPPING FEES** are payable to the stallion owner separate of the stallions service fee, unless otherwise specified.
9. It is the responsibility of the mare owner and the stallion owner to execute a Breeding Contract. The Gypsy Vanner Horse Society will provide the stallion owner with the mare owners contact information. The GVHS does not supply the mare owner with the Breeding Contract.
10. Should the stallion die or become unfit for service during the 2013 breeding year prior to the mare becoming pregnant, the mare owner may have an option to substitute another stallion owned by the stallion owner. If the mare owner chooses not to accept the offer, a credit will be given to the mare owner by the GVHS on another stallion in the sale, or a credit toward the next year sale. This credit shall constitute payment in full for any damages that may have arisen through this agreement. Any applicable live foal guarantee is between the stallion owner and the mare owner.
11. Relocation of a stallion does not prevent the breeding of a mare, the GVHS is not responsible for any relocation or the stallion.
12. Both mare and stallion owner assumes all risk of accident, injury or death to the mare or stallion, and specifically releases the Gypsy Vanner Horse Society, its officers, directors, representatives and agents from all liability for any and all injury or disability suffered by or sickness or death of the stallion, mare or foal from any cause whatsoever, and specifically waives any and all claims resulting from such loss, injury, disability, illness, or death. The GVHS does not assume liability for any disputes that may arise between the mare owner and the stallion owner. They specifically acknowledge and understands that the GVHS makes no warranties either expressed, implied or by any other means of interpretation in connection with this agreement.

By purchasing a stallion service through the GVHS Stallion Service Sale, it is understood that the buyer agrees to the above terms and conditions. By offering their stallion to the GVHS Stallion Service Sale, it is understood that the stallion owner agrees to the above terms and conditions.
