Submission of this application constitutes agreement to abide by the Association's Constitution and Bylaws. These can be found on the ABA website at [www.americanbar.org](http://www.americanbar.org). The ABA year runs from September 1 through August 31. Members joining after October 1 receive a prorated credit towards next year's dues. Section, Division, and Forum dues are not prorated. Membership dues are not deductible as a charitable contribution for income tax purposes, but may be deductible in part as a business expense. The ABA estimates that 21% of your total membership dues is allocable to lobbying activities of the Association, and therefore not deductible for income tax purposes as ordinary and necessary business expenses.
