All seniors from the class of 2013 who wish to attend the **LAST BLAST** event on Thursday June 20 to Friday June 21, 2013 must complete and sign this permission slip & conduct agreement along with a parent/guardian, and return it to the main office at Bernards High School by Wednesday June 12.

No permission slips will be accepted on Graduation Night.

Students attending the **Last Blast** event may not leave the school between the Graduation Ceremony and the departure for Life Time Fitness. At the conclusion of the Graduation Ceremony Reception (held in the lower gym), approximately 9pm, students will proceed to the cafeteria to board chaperoned buses for Life Time Fitness. The buses will return to BHS the following morning by 5:30am.

The parent/guardian of any student who has returned this permission slip, but fails to arrive for the boarding of the buses will be notified of the student's absence. All Bernards High School Rules of Conduct, as set forth in the school's Handbook, apply and are in effect for the duration of this event. The event will be fully chaperoned, and any student found to be under the influence of alcohol or drugs will be detained, and their parent/guardian will be notified to remove them from the event. Any student found to be in possession of illegal substances will be turned over to the police.

Any student behaving in a dangerous or destructive manner toward themselves, other persons or Life Time Fitness property or staff will have their parent/guardian notified, and will be removed from the event. Any student who fails to follow the rules of conduct, or who becomes ill during the event, **must be picked-up** by and only by the undersigned parent/guardian.

Please fill out the remainder of this form and **return it to the BHS Main Office by Wednesday June 12, 2013.** By signing this permission slip and conduct agreement your student agrees to follow the BHS Rules of Conduct at **LAST BLAST** 2013, and you agree to be responsible for them should they fail to adhere to those rules or becomes ill at the event.
