Rev. K. Ray Hill is a presenter certified by the FaithTrust Institute and an ordained minister in the United Church of Christ. He currently serves as Pastor-Teacher at Maple Temple United Church of Christ in Raleigh, North Carolina. Rev. Hill has 22

years of pastoral experience, seven of them in a rural setting and fifteen as an urban church pastor.

Rev. Hill served on the staff of the Southern Conference of the United Church of Christ for two years as an Area conference Minister and for five years as the Program Associate in Christian Education. He also served on the UCC's national staff as a consultant in Christian Education. Rev. Hill is an Education Consultant in the Southern Region for the Local Church Ministries of the UCC. He is also an instructor in UCC History, Theology and Polity for the Pastoral Leadership Development Program.

Hill earned his Master of Arts in Religion from Lancaster Theological Seminary in Lancaster, Pennsylvania, and his Master of Divinity degree from Duke University Divinity School in Durham, North Carolina. Hill also has engaged in extensive Continuing Education studies at the University of North Carolina in Chapel Hill and Drew Theological School in Madison, New Jersey.
