

Iowa Lakes Corridor Entrepreneurial Development Endow Iowa Fund

The Corridor has created a new Entrepreneurial Development Endowment Fund within the Okoboji Foundation Family of Funds. This fund gives us the ability to offer our donors the **Endow Iowa Tax Credit** available only through a qualified community foundation. With a contribution to this fund, taxpayers may be eligible to receive a 25% Iowa Tax CREDIT *in addition* to normal federal charitable income tax deductions for certain charitable gifts. This is an exciting program that benefits both donors and the Corridor.

Gifts to the Iowa Lakes Corridor Entrepreneurial Development Fund allow the Corridor to use your charitable contribution strategically in response to the most pressing entrepreneurial and economic development issues. Your contribution continues to support economic growth and development during and after your lifetime.

Special Incentive: Endow Iowa Tax Credits

The Iowa Lakes Corridor Entrepreneurial Development Endow Iowa Fund is part of the Okoboji Foundation Family of Funds, an affiliate of the Community Foundation of Greater Des Moines which is a qualified community foundation that provides access to Endow Iowa Tax Credits. Endow Iowa allows taxpayers to receive a 25% Iowa tax credit *in addition to* normal federal charitable income tax deductions for certain charitable gifts. Approximately \$4 million in Endow Iowa Tax Credits will be awarded annually.

The charitable gifts must be made:

- ☑ Through a qualified community foundation
- ☑ To a permanent endowment fund which limits distributions to 5%
- ☑ For the benefit of one or more Iowa charitable causes
- ☑ By individuals, corporations, or financial institutions

Endow Iowa: what an endowed gift could mean to you

Here is a brief approximation of the net after-tax costs of contributing to a fund:

Cash Gift (examples of different gift amounts)	\$1,000	\$10,000	\$100,000
Less tax benefits:			
Net federal/state tax savings (assuming maximum tax bracket)	- 400	- 4,000	- 40,000
Endow Iowa Tax Credit (before federal tax effect)	- 200	- 2,000	- 20,000
Net cost of contribution	\$ 400	\$ 4,000	\$ 40,000

Gifts of appreciated assets: The net cost could be even lower if capital gains taxes and/or alternative minimum taxes are avoided.

Why is the state of Iowa doing this? Between the years 2010 to 2020, approximately \$1.8 billion of wealth in Iowa will be transferred from one generation to the next according to research conducted by the Community Vitality Center at Iowa State University. Over this decade, it is anticipated that hundreds of millions of Iowa dollars will transfer to relatives who do not live in Iowa or to nonprofit organizations and institutions located outside of the state. To encourage Iowans to keep their assets in Iowa, the Iowa State Legislature established the Endow Iowa Tax Credit Program. This program provides incentive for Iowans to keep their assets here as a permanent investment in the betterment of Iowa communities.

How It Works:

- Tax credits of 25% of the gifted amount are limited to \$100,000 per person or \$200,000 per couple if both are Iowa taxpayers.
- Eligible gifts will qualify for credits on a <u>first-come/first-serve</u> basis until the yearly appropriated limit is reached. If the current available Endow Iowa Tax Credits have been awarded, qualified donors will be eligible for the next year's Endow Iowa Tax Credits. The Okoboji Foundation encourages donors to act sooner rather than later!
- Endow Iowa Tax Credits are a great way to support your philanthropic interests in the Iowa Great Lakes region now and into the future.
