10 miles south of Olympia, off I-5, take **exit #95 (Maytown)**, follow signs

COST: Weekend *: Family of 2= \$95 Single Adult over 18 = \$65
Family of 3 = \$115 Family of 4 = \$125 Family of 5 = \$135
Family consists of 1 adult and the rest children under 18
Day Rate *: Family - \$50 ** Single adult - \$30
(not staying overnight)

IF SPACE ALLOWS, Add an additional \$30/each for any non-family CHILD who attends with your family as a guest for the weekend.

FURNISHED: Use of cabin (sleeps 8 per cabin), 5 meals, community rest rooms/showers, safe swimming area (lake), fishing, row boats, canoes, and life jackets, trails, play fields, campfires etc.

BRING: Personal items, sleeping bag, towels, **hand soap**, lunch for Friday (if you plan to arrive early), flashlights, and **items for sharing: 2 dozen cookies per family, one (1) six pack of soda to be sold at campout, and 1 bag of chips.**
If at all possible, 2 pieces of firewood. The camp does not furnish firewood.
