

2013 Healthy Families, Healthy Planet Ambassador Advocacy Training Information and Application

The Project

Started in 2010 through the support of a grant from the United Nations Foundation, the Healthy Families, Healthy Planet project, an initiative of The United Methodist General Board of Church & Society, works to mobilize U.S. United Methodists on the importance of **maternal health and international family planning**. Through grassroots education with targeted annual conferences and advocacy efforts with policy makers, the goal of the initiative is **to achieve higher levels of foreign aid for international family planning through the U.S. government.**

Why family planning? Every two minutes somewhere in the world a woman dies from complications during pregnancy or childbirth. More than 222 million women desire to practice healthy birth spacing, but they lack access to the information and services that would empower them to do so. Family planning is critical to saving the lives of women and their children, and creating sustainable families and communities.

The Training

In response to God's call to care for the least of these, the *Healthy Families, Healthy Planet* Ambassador Advocacy Training is designed to bring together advocates from across the United States mobilize for a healthier world for mothers and their children. Since 2011, we have trained more than 75 Ambassadors across the United States. This year we will host our fourth advocacy training **October 27-30, 2013 in Washington, D.C.**

Together with health professionals, policy makers, and grassroots organizers, advocates will:

- 1. Learn the statistics and stories of global maternal health, maternal mortality, and the unmet need for family planning worldwide;
- 2. Train in effective grassroots and legislative advocacy from a faith-based perspective;
- 3. Develop advocacy skills and strategies for maternal health and international family planning within their communities;
- 4. Implement legislative advocacy with key policy makers on Capitol Hill;
- 5. Design action plans for at-home advocacy upon completion of the training.

All faith leaders in the continental United States are eligible for participation. An application can be found at the end of this document. Travel and lodging costs will be paid for by the project.

Selection Process

Healthy Families, Healthy Planet staff will review all applications and notify applicants of their acceptance by August 15, 2013. Strong preference will be given to applicants who demonstrate passion for maternal health advocacy, experience with organizing, thoughtful theological reflection, willingness to serve as a volunteer Ambassador for the project after the training, and strong communication skills.
