8	Section 1. Section 61-4-9.2 NMSA 1978 (being Laws 2008,
9	Chapter 44, Section 2) is amended to read:
10	"61-4-9.2. CERTIFIED ADVANCED PRACTICE CHIROPRACTIC
11	PHYSICIAN AUTHORITY DEFINED
12	A. A certified advanced practice chiropractic
13	physician may prescribe, administer and dispense herbal
14	medicines, homeopathic medicines, over-the-counter drugs,
15	vitamins, minerals, enzymes, glandular products,
16	protomorphogens, live cell products, gerovital, amino acids,
17	dietary supplements, foods for special dietary use,
18	bioidentical hormones, sterile water, sterile saline, sarapin
19	or its generic, caffeine, procaine, oxygen, epinephrine and
