- Describe the premise and key phases of the best-studied evidence-based therapy for adolescent Anorexia Nervosa: Family-Based Treatment (FBT), and
- Anticipate and troubleshoot the real-world clinical challenges of implementing empirically supported therapies with an acutely ill population in a non-eating-disorder-specialty setting.
