European Solar Days- For a Bright Future

The European Solar Days (ESD) initiative aims to raise public awareness for intelligent energy solutions, especially for Solar Thermal heating and cooling and for Photovoltaic electricity production. In 2012, the ESD will take place from 1-13 May.

ESD is a European project which aims to reach the European target of 20% of the total energy demand covered by renewables in 2020. The European Solar Days demonstrate the paramount importance in increasing the use of sustainable energies; solar energy in particular, including thermal and photovoltaic.

The event started in 2002 as the "Day of the Sun" in Austria and has developed into an annual full-blown pan-European campaign running over several weeks. The European Solar Days are celebrated in an increasing number of countries. In 2012 around 6,000 events are planned by diverse organisations ranging from schools and local authorities to solar equipment manufacturers.
