PFEW Prepares for Summer John Trombetta

Affiliate PACP member "Pennsylvania Free Enterprise Week" has begun preparations for its four, one-week sessions this summer in earnest. Plans for this year call for including nearly 1,500 students (rising high school juniors and seniors) in its internationally-acclaimed program designed to teach young adults to both understand and appreciate our private enterprise system. Now the largest program of its kind in the world, with similar programs in two dozen states and the countries of Australia and New Zealand, PFEW has now graduated more than 30,000 students over its storied thirty-three year history.

Unabashedly pro-business and proprivate enterprise in its curriculum, PFEW now partners with eighty-five PACP member chambers in "spreading the good news" about its work with the youth of Pennsylvania. During the months of January, February and March, information is being distributed to member businesses, schools and the greater service areas of each chamber. The effort has been to secure student scholarships, recruit volunteers and encourage students in literally every high school in Pennsylvania to take part in this one-of-a-kind educational experience that celebrates the world of business and Pennsylvania business specifically.

During their seven-day participation, each PFEW participant will play the role of an imaginary business owner, running mock corporations using a sophisticated computer simulation that enables them to experience all the pressures of running a business. Each
