Criteria for Selection

Citizen of the Year

- A nominated individual must <u>reside</u> in the City of Moreno Valley.
- A nominated individual will be judged on significant contribution to the growth and development of Moreno Valley and enhancement of the community's reputation. Some factors to consider are reasonable length of time of service contribution (approximately three (3) years) contribution in terms of more than one or two isolated activities and provision of activities and services that add to the quality of life in the community.

Business of the Year

- A nominated business must be a member of the Moreno Valley Chamber of Commerce.
- Nominated businesses will be judged on any combination of the following:
 - 1. Staying Power Minimum of one (1) year in operation
 - 2. Contribution to Community
 - 3. Innovativeness of Product or Service Offered
 - 4. Response to Adversity (if applicable)
 - 5. Involvement in the Moreno Valley Chamber of Commerce

Self-nominations are welcome for the Citizen of the Year and Businesses of the Year awards.
