**LIST OF NON-VIOLENT, NON-SERIOUS, NON-SEX CRIMES**

This list of non-serious and non-violent crimes was compiled by the Los Angeles District Attorney's Office. We then cross-referenced the LA DA's list with Penal Code section 290 and removed all the sex crimes. We then compared to CDCR's lists of Serious and Violent Felony Offenses to make sure there were no duplications. We found there were four crimes that were on both lists because of court decisions in *People v Gonzales* and *People v Guerrero*. Those crimes were PC 191.5 (Gross Vehicular Manslaughter while intoxicated), PC 192(c)(1) (Gross vehicular manslaughter not involving drugs), PC 192(c)(3) (Vehicular manslaughter not involving drugs or alcohol) and PC 12303.3 (Explode destructive device or explosive with intent to injure). Those four crimes have been removed from the below list.

Below you will find a list of crimes that I believe CDCR would deem to be non-violent, non-serious, and non-sex because these crimes are not on CDCR's list.

*Felony child abuse likely to produce great bodily injury or death, as defined in subdivision (a) of Section 273a. (Child Neglect)*

*Theft of a firearm (Penal Code Section 487(c)(2))*

*Any felony violation of Section 646.9. (Stalking)*

*Any felony violation of subdivision (b) of Section 368. (Elder Abuse – causing elder to suffer)*

*Solicitation of murder, in violation of subdivision (b) of Section 653f.*

*Any person who places or displays a sign, mark, symbol, emblem, or other physical impression, including, but not limited to, a Nazi swastika on the private property of another, without authorization (Penal Code Section 11411)*

*Any person who burns or desecrates a cross or other religious symbol, knowing it to be a religious symbol, on the private property of another without authorization (Penal Code Section 11411)*
