Rules & Conditions

The organizers will endeavour their utmost to ensure a pleasant and successful event.

Participants, however, participate and drive at their own risk and, by signing the entry form, waive all claims going beyond the limits of the vehicle-, personal- and event-liability-insurance coverage. No claims for secondary and/or punitive damages are admissible.

The organizers, their instructors and personnel cannot be held responsible for any personal or property damage occurring to participants before, during or after the event.

Participants, drivers and passengers are required to closely observe and adhere to all instructions, prescriptions and other advice communicated to them by the organizers and their personnel and instructors, both in written and/or verbal form. Wilful disobeying of instructions will lead to expulsion from the event, curtailing of insurance coverage and regress by the organizers for all damage not paid by insurances because of participant misbehaviour.

Participants, drivers and passengers will be held responsible for personal injuries and/or damage to property caused by non-adherence to rules, reckless and/or careless driving or negligent behaviour. Factory-ECOs and MonoTracers have adequate third-party-liability- and collision-insurance coverage.

A franchise of up to EUR 2,500.– might be charged if damage is caused to them or by them due to negligence of participants. This limit will be waived in cases of wilful misconduct leading to curtailing of insurance coverage as stated above.

By signing the entry form participants accept the domicile of PERAVES AG (= Winterthur, Switzerland) as the exclusive place for all litigation stemming from differences.

All people with a valid driver's license are entitled to enter as drivers. One passenger can be nominated for every driver entry. Minimum age for passengers is 16 years.

Duly registered vehicles (MonoTracers, ECOs, motorcycles and sidecars) are admitted if a liability insurance coverage of min. USD (\$) 1,000,000.– is documented. A limited number of factory-ECOs are available for rent.

The number of participants is limited and registration priority will follow the sequence of bank crediting of entry fees. Passengers will be registered according to the priority of the respective drivers. Entries are accepted by written confirmation until the max. number is reached. Additional entries then are rejected by refunding the fee(s) less bank charges. The organizers reserve the right to postpone or cancel the event in case of force majeure. In this case the entry fee will be refunded less banking fees and no other claims from participants are admissible. Participants may cancel their entries not later than May 31, 2011, by registered mail and the entry fee will be refunded less EUR 250.– handling charge. Later cancelling will result in the total entry fee(s) becoming forfeited.
