

Who Is Herman Cain?

Most of you know that the New World Order (NWO) already have their members in the top U.S. House and Senate GOP leadership positions. That would be Council on Foreign Relations' member Mitch McConnell in the Senate and Transatlantic Policy Network members John Boehner and Eric Kantor in the House. Herman Cain is one of thirteen U.S. business members who belong to the powerful **North American Competitive Council**. The council is part of the Security and Prosperity Partnership (SPP) that was established by the American, Canadian and Mexican government at the June 2006 Trilateral meeting in Cancun, Mexico. As you will see from the attached article, 'Sellout of America', the SPP plan is spelled out in detail in the CFR's 59 page document entitled, "Building a North American Community." It describes a five year plan for the establishment by 2010 of a economic and security community with a *common outer security perimeter*, i.e no borders between the three countries. "The council is expected to meet annually with security and prosperity ministers and will engage with senior government officials on an ongoing basis." There is no way Herman Cain or anyone else would be permitted to participate in such high level activities unless they had the full confidence of the NWO leadership. Could we really expect such an individual to faithfully protect the integrity of our nation's borders?
