Application for Grant to Assist with 2012 PLANC Conference Expenses**

With many institutions across the country facing difficult economic times, NAPLA has instituted a grant policy to assist a limited number of pre-law advisors attend the annual NAPLA or PLANC conference. Beginning with the 2010 conference, NAPLA provides up to \$1,000.00 to pre-law advisors to help defray some expenses involved with the conference. These grants are intended to provide assistance to individuals whose institutions will not provide funding for conference expenses.

Grant funding will cover some or all of the following expenses:

- Conference fee
- Overnight accommodations in dormitory space or lodging of comparable cost
- Transportation

Pre-law advisors who, without assistance from NAPLA, would not be able to attend the annual conference may apply for grant assistance by completing and returning a completed application, along with all other required material, to:
