Importance of EBP for Workforce Development

- Influences workforce recruitment
 - Markets agency as learning organization offering high quality services and professional development opportunities, etc.
- Affects the practice/supervision of child welfare staff
 - Offers clear expectations to workers/supervisors regarding high performance and fidelity with high quality interventions.
- Impacts organizational climate and retention
 - Shows agency's dedication to professional development, building a learning organization, etc.
 - Motivates staff to perform and to make a difference
 - Encourages staff to stay when their agency's organizational culture/supervision promotes evidence-based practices.

Why Evidence-Based Practice Now? (1)

- A growing body of scientific knowledge allows us to take a closer look at practices.
- Increased interest in outcomes and accountability by funders.
- Increased interest in consistent application of quality services.

Why Evidence-Based Practice Now? (2)

- Past missteps in spreading untested “best practices” that turned out not to be as effective as advertised.
- Continuing focus on safety and effectiveness of interventions.
- Impact of EBPs on worker retention and satisfaction.

CEBC Overview (2)

Goal of The CEBC:

- Provide easy access to information about child welfare related programs through a user-friendly website.



Information on Practices arranged in Topic Areas:

- Brief and detailed summaries for each reviewed program – each user can determine the level they want.
- Programs are rated on level of scientific support.





EBPs in Child Welfare

- Less is known about EBPs in Child Welfare than other areas such as medicine and mental health, etc.
- No one was looking specifically at EBPs for Child Welfare services and populations
 - Unique population with complex needs




CEBC's Definition of EBP for Child Welfare

What the CEBC Brings to the Equation...(2)

- Detailed information to help you determine if:
 - The program would be consistent with **Family & Client Values**
 - The program would fit with what your **Clinical Experience** says is needed

Child Welfare Relevance & Outcomes


- Each program is reviewed for its **relevance to Child Welfare Services** populations.
- Examines whether program has **outcomes related to the Child and Family Services Reviews (CFSRs)** in their published, peer-reviewed research:
 - Safety, Permanency, Well-being

Topics Currently on the Website

1. Anger Management, Domestic Violence, and Substance Abuse
2. Behavior Management including Parent Training
3. Core Child Welfare Services including Placement and Reunification
4. Engagement and Parent Partnering Programs



IMPLEMENTING EVIDENCE-BASED PRACTICES

Exploration Phase

- **Actively considering** the possibility of implementing an evidence-based practice.
- A key step involves **awareness** of an issue that needs to be addressed in a more effective way.

Sample Tasks in the Exploration Phase (1)

- **Work with stakeholders** to identify factors that may support or detract from effective implementation of a new program.
 - Funding issues
 - Existing agency policies and practices
 - Staffing issues

Sample Tasks in the Exploration Phase (2)

- **Determine what areas** need to be addressed with evidence-based practices.
 - Where do weaknesses currently exist in your services?
 - What data do you have on these issues?
 - What are the outcomes you want to see?
 - Drill down past symptoms to causes
 - Ask why 5 times

Sample Tasks in the Exploration Phase (3)

- **Consider which potential EBPs** target the core issues you want to address.
- **Develop internal support** for the changes at administrative and staff levels.
- **Consider the fit** of the potential EBPs in your organization.
 - Supervision process, IT, documentation requirements, referral process, workforce, etc.

Preparation Phase

- Agency has made the decision to adopt a specific EBP and is doing the planning and preparation work necessary to effectively implement it.
- Example:
 - Agency has decided to implement SafeCare with first time parents.

Sample Tasks in the Preparation Phase (1)

- **Work with stakeholders** to develop contracts or memorandums of agreement regarding referral, client engagement, and fidelity monitoring.
- Determine how the EBP services will be **funded**.

Sample Tasks in the Preparation Phase (2)

- Make sure that **timetables for staff training and certification** meet with existing service and productivity requirements.
- Address any **consumer concerns**, such as potential for stigma, applicability of practices for client needs and culture.
- Create or reinforce **referral pathways**.

Implementation Phase

- Agency is actively delivering the new practice in the community.
- Example:
 - SafeCare services are being delivered to families.

Sample Tasks in the Implementation Phase

- **Execute contracts** developed during the Preparation phase.
- Assess on-going **training needs**.
- Monitor **program indicators**.
 - Process
 - Outcomes
- Continue **working with stakeholders** to assess the impact of the program.

Sustainment Phase

- Agency has the new practice firmly in place and wants to continue it indefinitely.
- Example:
 - SafeCare becomes a part of routine services at the agency.

Sample Tasks in the Sustainment Phase

- Embed the practice in **agency materials**
 - Policy and procedure manuals, forms, new employee orientation, annual trainings, etc.
- Clarify long-term **funding streams**.
- On-going **fidelity monitoring and training**.
- **Evaluate** program to support sustainment.

Implementation Approaches

- Many different implementation models exist
- Little research on which models are effective (Few controlled studies)
- ARC (Availability, Responsiveness, Continuity)
- CDT (Community Development Teams)
- Breakthrough Series

Factors for Successful Uptake

- Careful planning before deciding what, if anything, to adopt.
- Data driven decisions.
- Training is necessary, but not sufficient.
 - *The “train and hope” approach does not work*
- On-going monitoring and reinforcement.

Examples

- **SafeCare**
 - Statewide in Oklahoma
 - California

- **TF-CBT**
 - Arkansas

- **MTFC**
 - Cal-40 study in California

Trends (1)

- **Dramatic increase in number of solid research studies on interventions relevant to child welfare.**
- **Dramatic increase in use of EBPs over the past decade.**
- **Funders are requiring the use of EBPs.**
 - Let the buyer beware: “Evidence Based Practice” as a marketing term...

Trends (2)

- **Emergence of Implementation Science.**
- **Recognition of the role of trauma in development of individual and family problems and use of that insight in development and testing of intervention models.**

Challenges (1)

- **Defining what an EBP is**
 - EBP as a “marketing term”
 - Need clear definition of what is meant by EBP

Challenges (2)

- **Political challenges**
- **State vs. County driven child welfare systems**
- **Partnering with other sectors**
- **Challenging the status quo**
- **Restricting to a single defined list of EBPs**

Challenges (3)

- **Workforce issues**
 - Match of skill set, compatibility, culture and climate
- **Training staff in multiple models**
 - How many do you need?
- **Staff turnover and retraining**
- **Fidelity and drift over time**

Challenges (4)

- **How to fund EBPs**
 - Many not fit cleanly in existing funding streams
- **Incorporating EBPs in Social Work curricula**
 - What to include?
 - Are field placements using EBPs?

Challenges (5)

■ Art vs. Science

- The concern that EBP does not address practitioner's expertise

■ Application with Diverse Groups

- Using EBPs with Cultural and Ethnic groups

- **Practice Based Evidence**
- **Common Elements**
