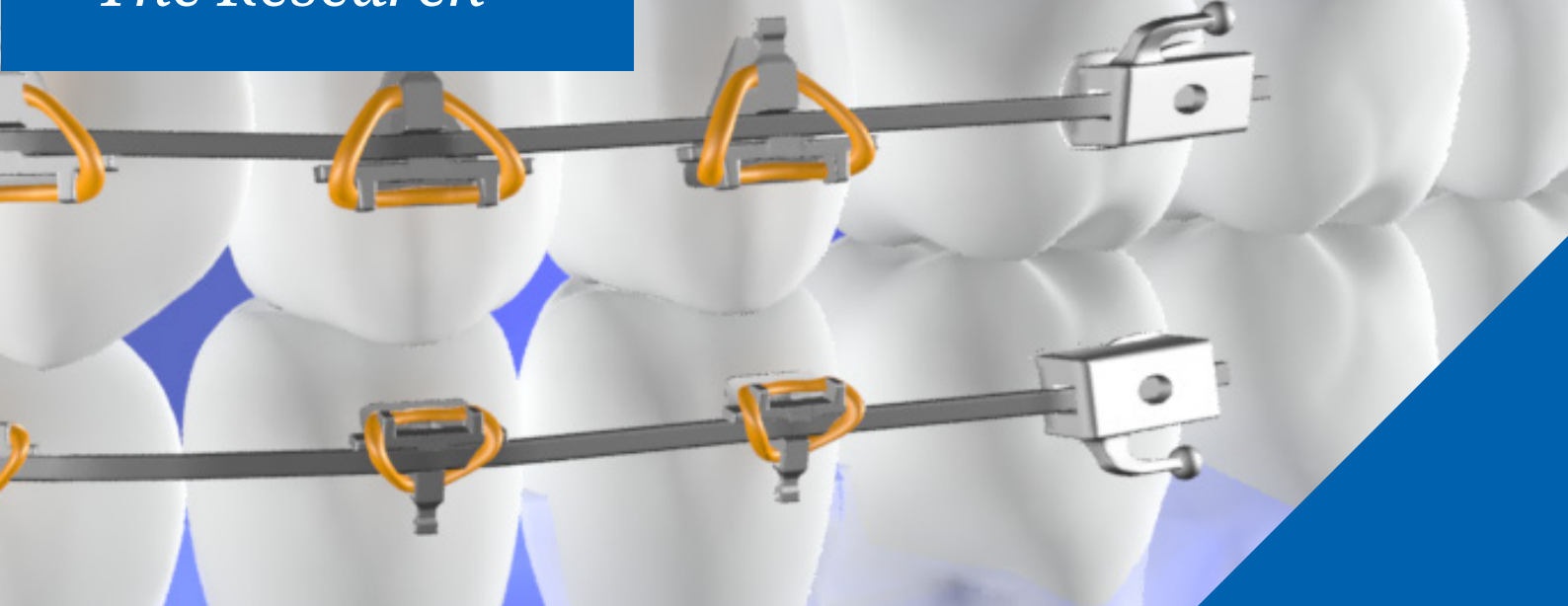

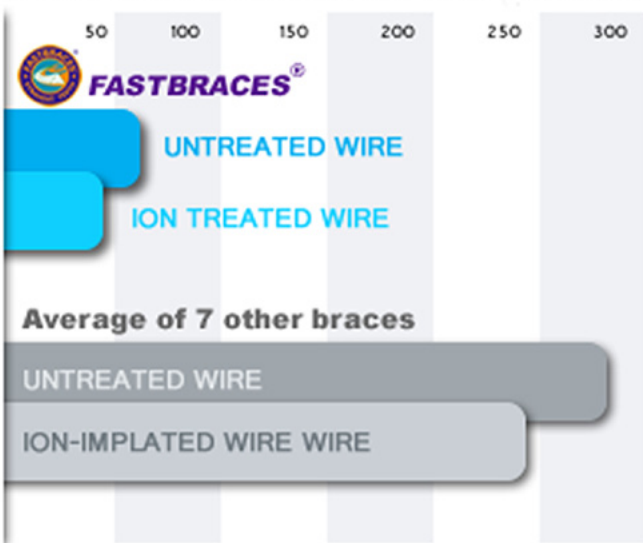

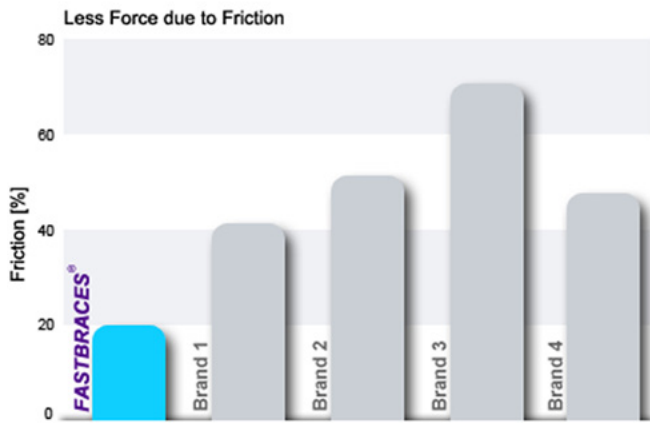

Frictional Resistance to Motion (Grams of Force)



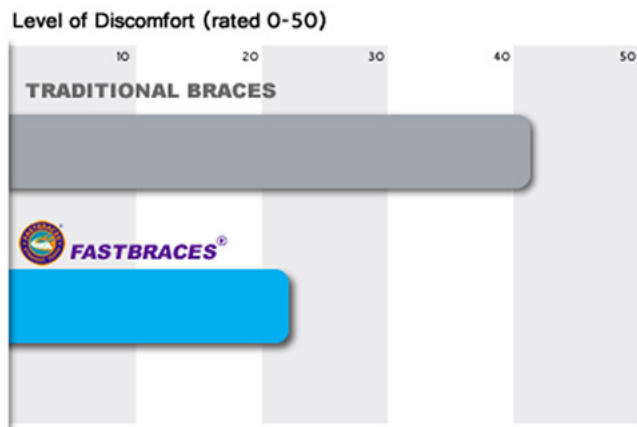

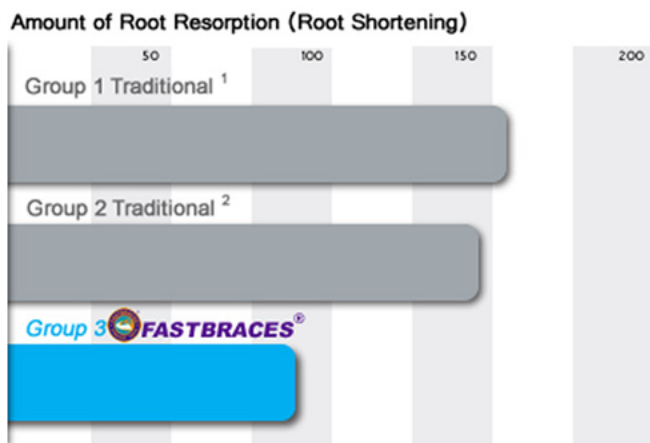


