Margaret Allman


arlier this year, Columbus House learned of the passing of one of our long time supporters,
Margaret Allman, of New Haven.
Margaret attended Hill House High
School and then went on to earn a
Bachelors Degree in Science at Albertus
Magnus, a Masters at Yale School of
Nursing and yet another Masters at the
University of California, Berkeley. She
worked at Fort Monmouth, NJ as a
laboratory assistant during World War II
in the Signal Corps.

She was Assistant Professor and Chairman of the Medical-Surgical Nursing Department of the University of Bridgeport College of Nursing and was elected to the Board of Trustees of Albertus Magnus College.

She taught at the Southern Connecticut State University School of Nursing since it's inception in 1972 up until her retirement. Margaret was a socially conscious woman with numerous interests. She traveled extensively as a faculty advisor to foreign nursing students from developing countries under a World Health Organization fellowship. She also enjoyed taking the Metro North into New York City.

Dedicating herself to others throughout her lifetime, it was no surprise that Margaret bequeathed her assets to various universities and charitable organizations.
